## General

## What is Mijn NN Zakelijk?

The new Mijn NN Zakelijk is a single location where you can manage all your company's business products. We offer handy links with external bodies to minimise your administrative work and we are making it even easier to submit updates.

Mijn NN Zakelijk has been developed in close consultation with customers and advisers and so, for example, there are no unnecessary inputs. And navigation through the screens is much improved. The look & feel is also better.

## The advantages of Mijn NN Zakelijk

### 1. Focus on convenience and simplicity

We only ask you to input information we cannot get from other sources such as the Employee Insurance Agency (UWV) and the Personal Records Database (BRP). The information display is stratified: you see the most important information immediately and then click down for more detail.

## 2. Minimising your administrative work with automatic links to municipalities, the UWV and other bodies

For example, you no longer have to submit changes of address unless someone lives abroad. We also process information on civil status automatically. See the Civil status and children event card for more information.

## 3. Performance

We have worked to create an even faster environment that meets all the requirements for a modern website.

## 4. Everything in one place

- 1. Submit updates.
- 2. Information brought together for each employee.
- 3. Documents available (for example, the Pensioen 1-2 and pension regulations and administration agreement).
- 4. Overview of all billing statements and financial status.

### 5. Live help

If you want, we can look in with you live. During the phone call we will ask you to authorise us to look in so that we will be able to help you even better.

### 6. Secure environment

The world around us is changing and security is really important. Mijn NN Zakelijk has the latest security features to best protect your information (and ours). The General Data Protection Regulation (GDPR/AVG) also sets strict rules for this. We no longer share certain information in Mijn NN Zakelijk as standard. More was available in the old environment but now, for example, no information on addresses or partners is displayed. Nationale-Nederlanden has an interface with the BRP (Personal Records Database, formerly the GBA) and we are not allowed to share data from it.

## **Access management**

## General

You can add users in Mijn NN Zakelijk. This could be a member of your organisation's HR staff or an external adviser or trust office. **Important:** At the moment it is not possible to set up roles and authorities. As a result, anyone you add now will be able to make updates. We will adjust this in the course of 2020.

- ✓ All active employees are displayed under Werknemers along with their monthly premiums.
- ✓ Non-active employees can be seen in the employee list for up to one year so that you can check that the leaving date has been processed correctly.
- ✓ Click on the employee for more information and to manage that employee.
- $\checkmark$  You can add an employee to the workforce from the list of employees.
- Click on download a list of employees to get a CSV file listing information your employees. This file shows the accrued entitlements/insured amounts, total premiums and a breakdown of the cover for each employee.
- Click on Meerdere werknemers toevoegen to download a template for information to register several employees at the same time.
- ✓ This also applies to Meerdere werknemers uit dienst melden. Here you download a template you can use to input several employees who are leaving at the same time. You can then upload it.
- Click on Meerdere salarissen en parttime percentages doorgeven to input new salary information for several employees at the same time.
- Click on Mutatieoverzicht downloaden to review the updates you have sent via Mijn NN Zakelijk. This list does not gives status information but acts as a logbook so that you can clearly see at any time what updates (and the related values) you have sent and when.

- ✓ If an employee is married, in a registered partnership or cohabiting (meeting the definition of a partner) click on Ja in the question Is er een partner bekend?
- ✓ An additional tab Partnergegevens is displayed.
- ✓ If the unspecified partner system is in use, the question Is er een partner bekend? is not displayed.
- ✓ Complete the employment starting date and click on Volgende.

## Partner information (if there is a known partner)

- ✓ State the civil status in Burgerlijke staat.
- ✓ In the case of a marriage or registered partnership, we will retrieve the partner's information from the BRP. You do not need to input any further information.
- ✓ We cannot retrieve this information for a cohabiting partner and so you have to input the information manually.
- ✓ Click on Volgende.

### **Salary information**

- ✓ Input the salary information and part-time percentage.
- ✓ You can also input part-time salaries or salaries per week or four weeks.
- ✓ The salary is always converted into a full-time annual salary that is processed in our records. You see this amount in the Berekende basissalaris field.
- Click on Aanmelden to register the employee. Important: The update is sent immediately. You can click on Terug to check what you have input. What you have input remains in place.

- ✓ You will, however, see whether the employee has a partner listed in our records.
- ✓ You can see at a glance what the employee is insured for and the related total premium.

- ✓ Click on the Maandelijkse Premie bar to open the drop-down.
- ✓ The drop-down displays more information, such as policy numbers and product names.
- ✓ It also displays the breakdown of the premium for the various products and insurance cover.

## **Updates for one employee**

## General

Nationale-Nederlanden uses a BRP interface and so you no longer need to provide the following updates:

- ✓ Marriage/registered partnership
- Divorce/end of registered partnership
- Death
- ✓ Address update unless abroad

Nationale-Nederlanden also uses a UWV interface and so you no longer need to provide the following updates:

Occupational disability

The disability interface submits new registrations, updates and recoveries. You see the employee's disability percentage and the effect on the premium.

Important: if you have a Persoonlijk Pensioen Plan (formerly through Pensioen Services Online), we only receive reports of a change in disability percentage from the UWV. We are not notified by the UWV when an employee has been ill for two years. You have to report this to us yourself. See the 'Reporting disability in the Persoonlijk Pensioen Plan' event card.

## Salary/part-time percentage update

- ✓ Input the new salary information here. If there are separate salary elements, these fields are also displayed.
- ✓ Input the new part-time percentage.
- ✓ Click on Mutatie verwerken to process them in Nationale-Nederlanden's records.

### **Employee leaving**

- ✓ Input the first day that the employee is no longer employed. For example: Ms J. van den Akker leaves on 31 October 2020. The first day that she is no longer employed is 1 November 2020. Fill that date in.
- ✓ Click on Mutatie verwerken to process it in Nationale-Nederlanden's records.

### **Registering a partner (including cohabitation)**

(where there is specified partner cover)

- ✓ Register a cohabiting partner with us as we do not get this information from the BRP.
- Complete the information on the cohabiting partner and the date from which the partner should be registered for a partner's pension.
- ✓ Click on Mutatie verwerken to process it in Nationale-Nederlanden's records.

Send an email to your client manager to insure the Anw shortfall pension. ## Registering/deregistering for voluntary Anw shortfall pension for a Persoonlijk Pensioen Plan (formerly through Pensioen Services Online)

- ✓ If you have an opt-out scheme, the Anw shortfall pension is insured if you register the partner. You register the employee through the portal. If you have an opt-in scheme, send an email to your client manager to insure the Anw shortfall pension.


